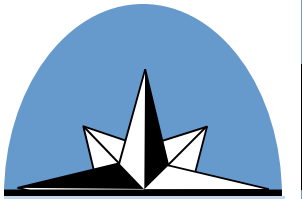
Anyone who has not called me regarding dinghy storage, please do so as following : **Jim Conti**

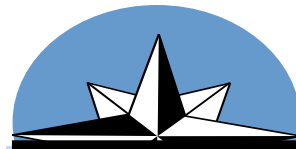
House Managers Report

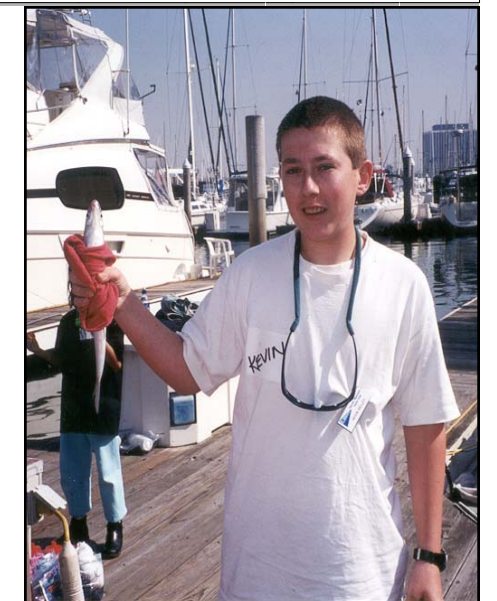


