## **RIGHTS AND PRIVILEGES**

Regular Members hold all rights including voting and holding elective.

Associate Members and Junior Members rights are as set forth in Article III of the By-Laws. Spouses of Regular Members are Associate Members. Associate Members or Junior Members may not vote or hold elective office.

Applicants for any class of membership hold no rights or privileges, other than release from the stricture that he/she be specifically invited to the Clubhouse. Applicants may use the Club facilities at times when the Clubhouse is open. Applicant may not serve himself/herself, nor be in the Clubhouse when a member is not present.

## SOME CLUB RULES

PMYC is a do-it-yourself club, and every member is responsible for maintaining the Clubhouse. Pick up after yourself, your guests and others.

Only Regular Members and Associate Members are allowed behind the bar.

The Clubhouse may not remain open unless a member is present.

As set forth in Article XI of the By-Laws, any member whose conduct or behavior reflects badly upon the Club, impairs the good name of the Club, or disturbs the harmony of the Club, may be disciplined by the Staff Officers Council. Such discipline may include a disciplinary warning, suspension of a specific membership privilege for a specified period of time, or expulsion of all membership privileges for a specified period of time, or expulsion from the Club and termination of all membership privileges.
